Further, the undersigned hereby submits himself (herself) to the jurisdiction of the Courts of South Carolina in the event suit is brought in connection with any claims by Commercial Industrial Supply, LLC regarding this guaranty of payment, and agrees that venue shall be in the county where Commercial Industrial Supply, LLC has its principle place of business. It is understood and agreed by the undersigned that this personal guaranty shall remain in full force and effect regardless of whether the below named corporation, partnership, or sole proprietorship files bankruptcy, becomes insolvent, or is otherwise dissolved. The undersigned personal guarantor, recognizing that his or her individual credit history may be a necessary factor in the evaluation of this personal guaranty, hereby consents to and authorizes the use of a consumer credit report on the undersigned, by the above named business credit grantor, from time to time as may be needed, in the credit evaluation process.
